Lifetime Achievement Award Program

The Construction Safety Group of Kansas City (CSGKC) **Lifetime Achievement Award Program** honors one individual annually who has shown outstanding commitment, leadership, mentorship, and innovation in the field of occupational health and safety (OHS) throughout their career. This prestigious award celebrates a legacy of sustained contributions and dedicated involvement in CSGKC, recognizing those who have made a lasting impact on the OHS profession.

Eligibility Criteria

Nominees must meet all the following requirements:

- Be a current Professional or Emeritus Member in good standing of the CSGKC.
- Have maintained CSGKC membership in good standing for at least ten (10) consecutive years.
- Possess a minimum of twenty-five (25) years of professional experience in the field of OHS.
- Demonstrate a lifelong commitment to OHS.
- If applicable, be in good standing with relevant professional bodies or certifications, such as CSP, CIH, CHST, STS-C, CRIS, ARM or equivalent.
- Must not have previously received the Lifetime Achievement Award from CSGKC.

Nomination Requirements

A complete nomination package must include the following:

- **Completed Nomination Form**
All required fields must be filled out accurately.
- **Minimum of Two (2) Letters of Support**
Letters may be submitted by colleagues, employers, industry peers, or representatives of professional associations. Letters should detail the nominee's career achievements, influence on the OHS profession, and lasting contributions to the CSGKC.
- **Comprehensive Résumé or Curriculum Vitae (CV)**
The résumé or CV should include:
 - Professional work history
 - Leadership roles
 - Certifications
 - Publications
 - Awards and honors
 - Professional affiliations
- **Summary of Major Career Achievements**
This summary should highlight:

- Leadership in the field of OHS or organizations.
- Development and implementation of impactful OHS initiatives.
- Contributions to industry standards, education, or policy.

Evaluation Criteria

Submissions will be evaluated based on the following:

- **Impact and Legacy** – Evidence of long-term influence on OHS and the broader profession.
- **Leadership and Innovation** – Demonstrated ability to lead change and implement innovative OHS practices.
- **Professionalism and Ethics** – Adherence to the highest standards of professional integrity and ethical conduct.
- **Mentorship and Advocacy** – Ongoing efforts to mentor OHS professionals and promote a strong safety culture in the construction industry.
